





RELATIVE RADIANT SENSITIVITY vs. ANGULAR DISPLACEMENT












Collector Dark Current vs. **Collector-Emitter Voltage**





REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS








A-A Section
