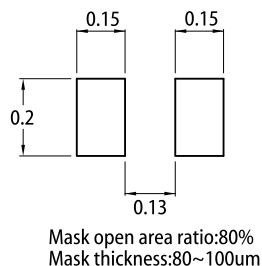

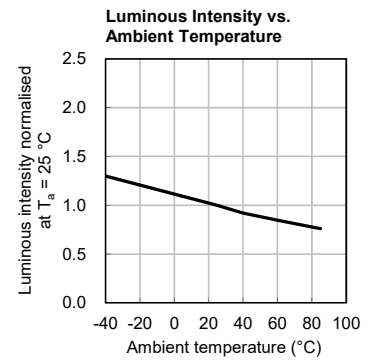
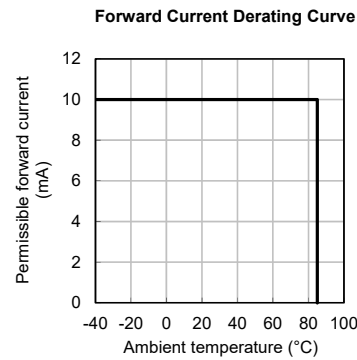
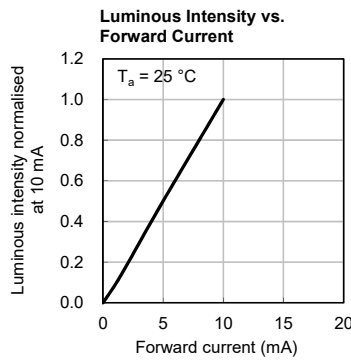
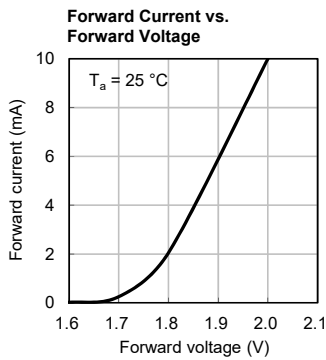
#### RELATIVE INTENSITY vs. WAVELENGTH



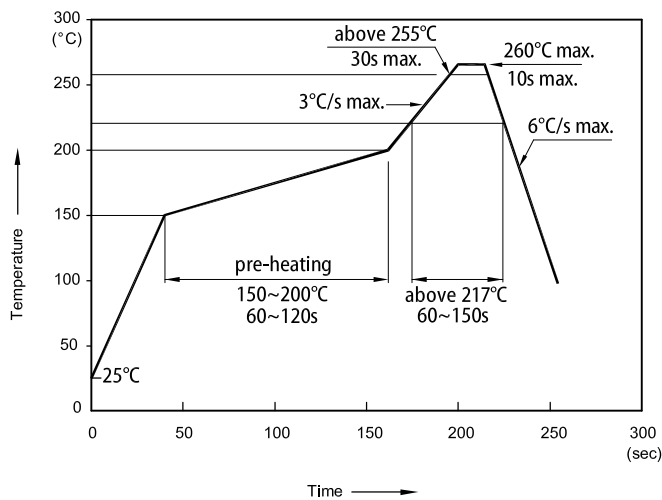
#### SPATIAL DISTRIBUTION



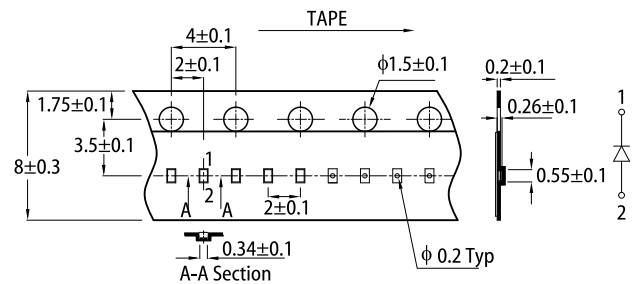

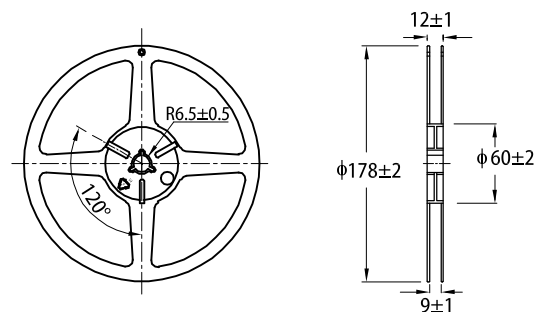
#### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

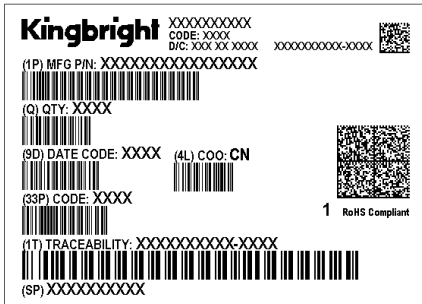
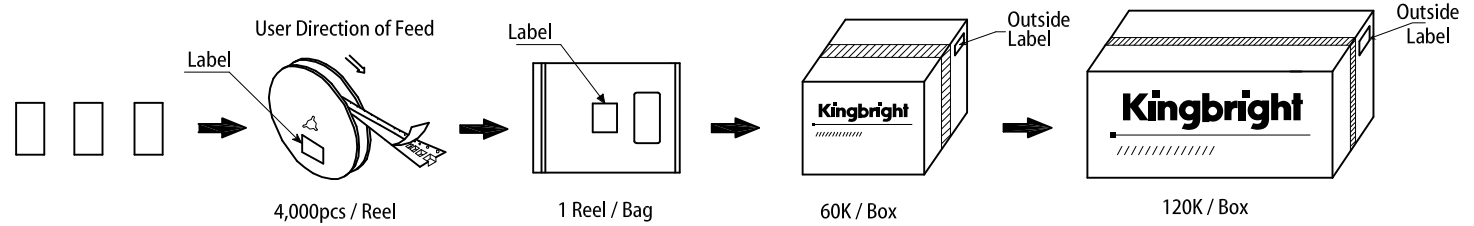


#### REEL DIMENSION (units : mm)
