


### **RELATIVE INTENSITY vs. WAVELENGTH**





### **SPATIAL DISTRIBUTION**












## **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**





# TAPE SPECIFICATIONS (units:mm)




## **REEL DIMENSION** (units: mm)
