#### **RELATIVE SPECTRAL SENSITIVITY vs. WAVELENGTH**




### **RELATIVE RADIANT SENSITIVITY vs. ANGULAR DISPLACEMENT**

























# **REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS**



#### TAPE SPECIFICATIONS (units:mm)




## **REEL DIMENSION** (units:mm)
