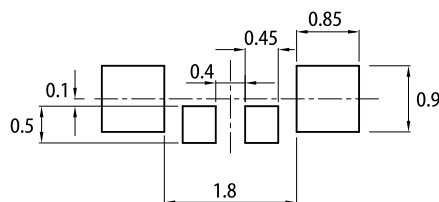

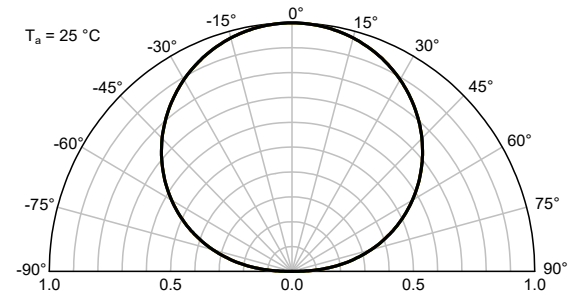

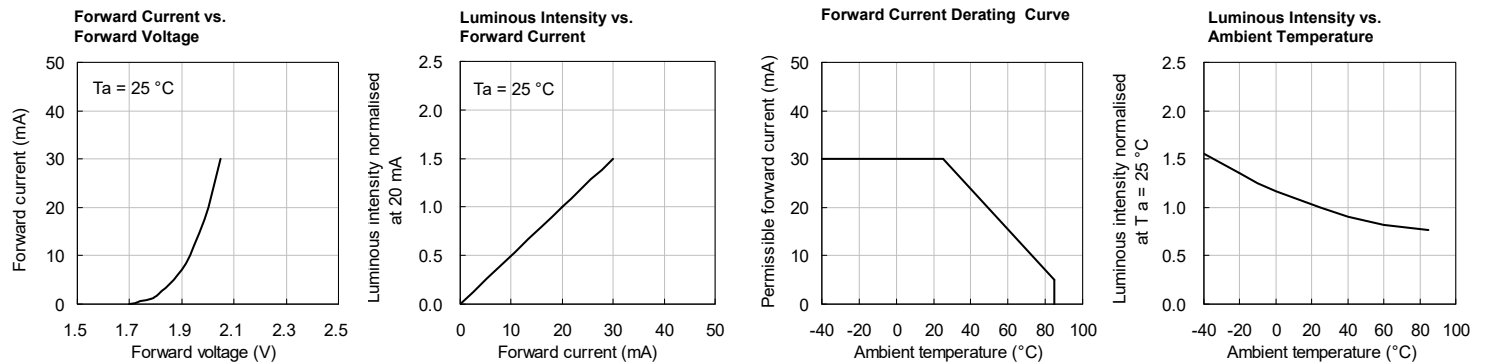
#### RELATIVE INTENSITY vs. WAVELENGTH



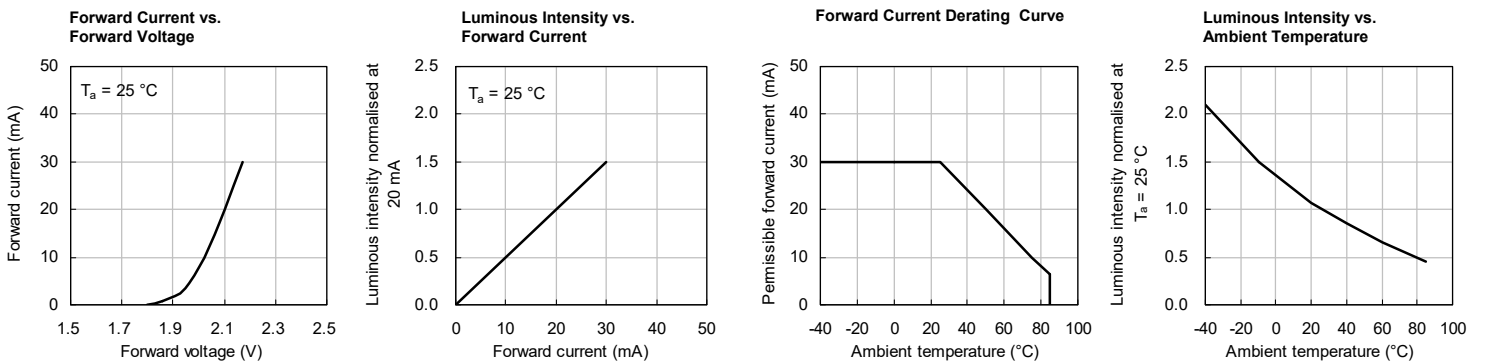
#### SPATIAL DISTRIBUTION

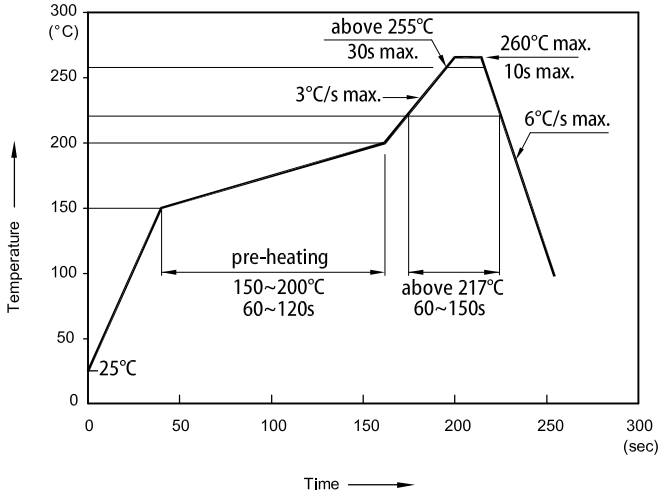

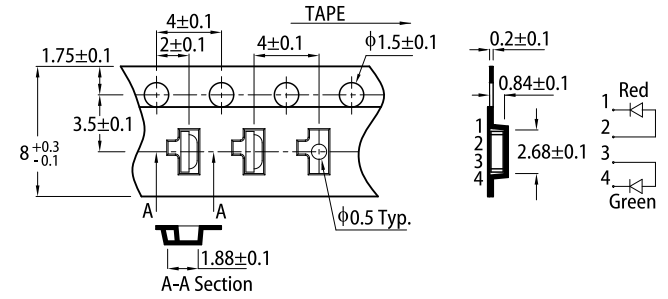


### REFLOW SOLDERING PROFILE for LEAD-FREE SMD PROCESS

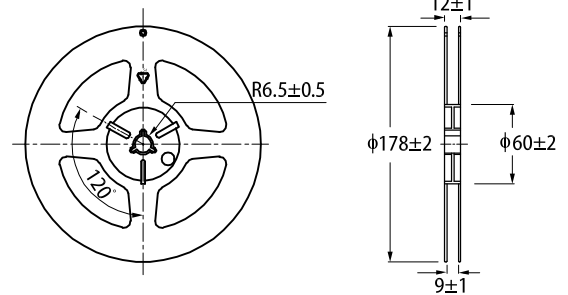

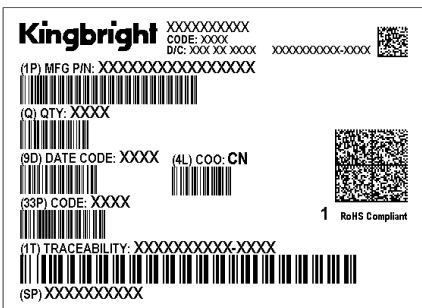
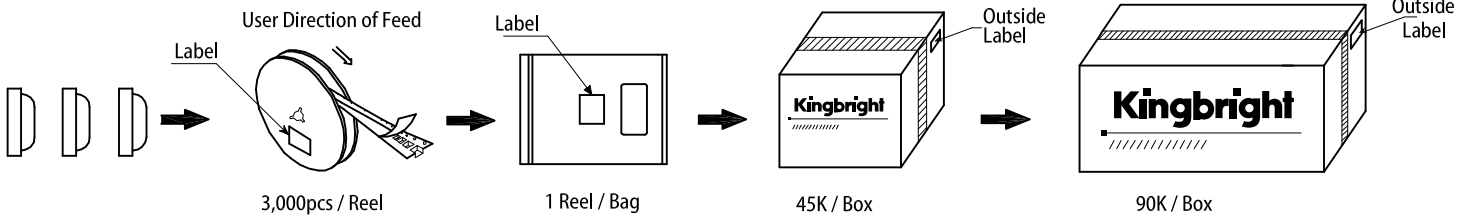
- Notes:
